

# Court to hear case of 6-year-old traumatized by teacher insisting ‘girls aren’t real’

## — By Justice Centre for Constitutional Freedoms

The girl’s family brought the claim for discrimination on the basis of gender identity, for teaching the child and her class there are no such things as girls or boys.

OTTAWA, March 5, 2020 (Justice Centre for Constitutional Freedoms) — The Ontario Human Rights Tribunal has ordered that the case of a young girl (“NB”) and her mother against the Ottawa-Carleton District School Board, the child’s former teacher and the principal of the school, will proceed to a full hearing. The Tribunal has dismissed an application from the school board for a summary hearing — an attempt to have the case dismissed at an early stage of proceedings. The school board argued unsuccessfully that the child’s case had no reasonable prospect of success and should not be permitted to proceed.

The family brought the claim for discrimination on the basis of gender identity, for teaching NB and her class there are no such things as girls or boys. NB identifies strongly with her biology as a girl. The Justice Centre for Constitutional Freedoms ([jccf.ca](http://jccf.ca)) filed an amended application on the family’s behalf, including a claim for discrimination on the basis of sex, noting the child’s rights to security of the person and equality under sections 7 and 15(1) of the Canadian Charter of Rights and Freedoms had also been infringed.

In early 2018, NB was a 6-year-old student in a grade one class taught by “JB”. The teacher showed the class a YouTube video entitled, “He, She, and They?!? — Gender: Queer Kid Stuff #2”. The video contained a number of statements about gender identity, and asserted that “some people aren’t boys or girls” and that those who do not feel like a ‘she’ or a ‘he’ might not have a gender. In order to determine who is a girl or a boy — or neither, the video says, all you have to do is ask someone their pronouns.



On another occasion, the teacher drew a gender spectrum on the board and asked each student to identify where they fit on the spectrum. NB indicated that she was on the furthest end of the spectrum marked “girl.” The teacher then told the class that “girls are not real, and boys are not real”. This was extremely upsetting to NB.

NB went home and told her parents, repeatedly asking why her identity as a girl was “not real.” She stated that she was not sure if she wanted to be a

mommy when she grew up, and asked if she could “go to the doctor” about this issue. NB also expressed feeling that she “had to do something” about the fact that she is a girl. This followed a lesson by the teacher on the concepts of gender spectrum and sex changes.

Neither the school nor the teacher obtained parental consent to teach this young child that her sense of self as a girl was a fiction. The parents allege that the teacher’s conduct undermined their daughter’s foundational concept of identity, and also contradicted biological reality.

Despite the family’s expression of concern, school officials refused to take any steps to correct the impact of these lessons on NB. Ultimately the family opted to move her to a different school, which made NB happy that she would no longer have a teacher who said that “girls are not real.” Even after moving to the new school, NB continued to be upset by her experience in JB’s class, and grappled with the concept that her own identity was not something real. Her mother was concerned enough to seek guidance from a psychologist on how to assist her daughter, according to the application.

Some gender theorists and activists now argue not only that “gender identity” is on a spectrum, but that sex is also on a spectrum, meaning that there are no longer distinct categories of male and female. Among other things, the family is asking the Tribunal to rule that the school board stop “teaching gender theory in any manner which suggests that sex categories of male and female do not exist, or are fluid, or exist on a spectrum.”

In its application to have the matter dismissed at the summary hearing stage, the school board argued that classroom discussions about gender identity and gender expression cannot be the basis of a Human Rights Code infringement. In its response, the Justice Centre argued on behalf of the family that gender identity is a new concept which is poorly defined and logically convoluted. As a protected ground under the Code, it is important that the Tribunal develop a body of case law to understand the limits and manifestations of discrimination under this ground, especially when it conflicts with protections previously in existence, namely that of sex — particularly for women and girls.

“If everyone has a gender identity, and gender identities are protected under the Code, then NB’s gender identity as a girl should be protected,” said Justice Centre staff lawyer Lisa Bilyd. “If the School Board can accommodate the inclusion of trans and other gender identities into the classroom setting, then surely they can accommodate the inclusion of children who experience no discord between their biology and their sense of self.”



# The Pastoral Point—Proclaiming Truth in a World of Uncertainty (Feb. 2020)

## Unspeakable Evil...Why?

*Therefore, hear me, you men of understanding: far be it from God that he should do wickedness, and from the Almighty that he should do wrong.— Job 34:10 (ESV)*

This past week has captured our minds and our hearts with the tragic disappearance and subsequent murder of Faye Swetlik. A beautiful 6-year-old girl who was full of life and smiles. My immediate reaction was that this was such an “unspeakable evil.” I was reminded of another time an unspeakable evil captured the nation’s attention when Susan Smith killed her 2 children by strapping them in the car and deliberately allowing the car to go down the boat ramp into a pond drowning both her boys.

How do we explain such evil? How do we reasonably understand this without going insane? For the unbeliever, there is no hope in finding answers. These events and many like them would be just a meaningless collision of choices that purposeless people make. It is utterly hopeless. And even for the Believer, this can sometimes shake us deeply and we wonder, “How could a loving God allow such evil to take place?”. If He is an all-knowing God and all-powerful, how can He know this evil is happening and have the power to stop it, and yet not act? And since God is the Sovereign Ruler of this universe and rules in the affairs of men, then is this the plan and purpose of God? These are hard questions and many of us find our minds going right here.

So...when unspeakable evil happens, it is natural that we often find ourselves asking lots of questions. How can a beautiful 6-year-old girl be taken from the protection and love of her mother and father and be murdered and discarded as meaningless garbage? We wonder, why God would allow such evil in the world and how is it that His fiery wrath is not dispensed from Heaven with speed to satisfy the Justice of God?

Although it would take much more to explain all that Holy Scripture says

about evil and its allowance and purpose by God, I give you a few points to keep in mind as you navigate through your thoughts about such an unspeakable evil.

## 1. We live in a fallen sin cursed earth.

Sadly, this is the natural result of a fallen and sinful world. We are reminded of this every day with the reality of how fragile life is and how sin and death permeate our world. Not long after the fall of man in the garden, blood was spilt with the murder of Abel. Also by the time we get to Genesis 6 the earth is full of evil and violence to the point that God says he was sorry that he had made man and decides to destroy them all with a flood. The fact that evil happens should not shock us, but sometimes the degree to which man can go with his evil heart does. Because of sin, men are capable of the worse forms of evil as Jeremiah says, “The heart is deceitful above all things, and desperately wicked; Who can know it?” (Jer. 17:9)

## 2. The Devil is the god of this age.

The Devil works tirelessly to blind people to the truth and lead people into evil as Paul reminded us in I Corinthians: “But even if our gospel is veiled, it is veiled to those who are perishing, whose minds the god of this age has blinded...,” 2 Corinthians 4:3–4 (NKJV). Jesus said he was a murderer from the beginning (John 8:44). And lost people are identified as “children of the Devil” in I John 3:10.

## 3. Evil men are getting worse and worse.

Scripture is clear that as man and society move away from God and His Word, men will manifest more and more evil (Romans 1:18-28); Two things can occur in this situation. First, the grace of God is removed and the restraint that God gave for evil is removed. Second, the evil that is resident in all of our hearts is allowed to express itself with no internal restraint of the conscience and no external restraint due to the collapse of a moral society governed by the principles in the Word of God. (2 Tim 3:1-5)

## 4. God is Sovereign over the worst forms of evil.

The fact that God is Sovereign is not a debatable issue. God is not God if He is not sovereign. The issue is how do we understand God’s rule over evil. Scripture clearly teaches that while God is not the author or efficient cause of evil, He does exercise control over it. He doesn’t in any sense approve of

evil, ratify it, look on it with favor, give it His blessing, or delight in it; but nothing happens outside of His sovereignty. Consider the case of Job—God turned Satan loose for horrendous evil in the life of Job. All the suffering Job endured at the hands of Satan happened under the Lord’s authority; none of it occurred outside the plan and power of God. None of it could have occurred if God had not willingly permitted it. (*The Truth About Evil*, by John MacArthur Tuesday, January 17, 2017)

Hope and comfort can only be found in the fact that God is ultimately in control of the existence and purpose of evil. Consider this... there are only 4 possibilities for who is in control of evil; Man, the devil, chance or God. The only one that brings comfort and hope is God, and that is exactly what the Bible affirms, “I form the light and create darkness, I make peace and create calamity; I, the Lord, do all these things.” (Isaiah 45:7). Also the greatest evil ever conceived of in the mind of man was the murder of the Son of God on the cross, yet this is clearly said to have been under the control of God. (Acts 2:23; 4:26-28, Gen.50:20,Rom. 8:28)

## 5. This is gracious reminder of the need for Christ.

The most important thing you can learn from this tragic event is that you need to saturate your family with the gospel of Christ. We will all die...us and our children, so we need to be prepared to meet God. In response to some unspeakable evil and a tragic event Jesus had a important reminder for all of us, “Do you suppose that these Galileans were worse sinners than all other Galileans, because they suffered such things? I tell you, no; but unless you repent you will all likewise perish. Or those eighteen on whom the tower in Siloam fell and killed them, do you think that they were worse sinners than all other men who dwelt in Jerusalem? I tell you, no; but unless you repent you will all likewise perish.”(Luke 13:2–5) It must be stated that all of the thoughts I offer are an affirmation that the Bible is true, and it is the only means by which we can understand the existence of such evil and most importantly that the Gospel of Christ is our greatest need.




